## MEMBERSHIP AGREEMENT

Welcome to The Art Group Gallery (TAGG) -- a 501(c)(3) non-profit, cooperative Gallery. As a cooperative, all artists share in the day to day operations of the Gallery including; selling each others art and crafts while working in the Gallery, teaching art and making decisions and the cleaning and general maintenance of our building.

### Membership Options

Membership dues are charged based on the square footage on which the artist exhibits , combined with the amount of the artist/artisan’s involvement in running the Gallery.

Note: A 3' x 7' (21 sq ft) space holds 5 small, 4 medium or three large paintings.

**Case Rental Options** - Jewelers and other artists who prefer case rental as opposed to wall space rental have the following options for monthly case rental.

1	One glass case for \$25. per month. Sit the gallery 2 days a month.
2	One glass case for \$35. per month. Sit the gallery 1 day a month.
3	One glass case for \$45. per month. Sit the gallery 0 days a month.

It will be the responsibility of the artist to arrange art within the case and to maintain the interior of the case.

**Greeting Cards** - Artists exhibiting **only** greeting cards will not be subject to monthly membership dues and will pay the Gallery 30% commission on all sales. Cards must be presented in protective glassine envelopes.

The undersigned artist/artisan agrees to:

- Notify TAGG immediately if contact info changes
- Provide the Gallery with an artist biography
- Present work properly framed and ready for hanging or display if 3-D art. All frames must have hook eyes and wire for hanging. Saw-tooth hangers are not permitted. Frames, glass and mats must be clean and in good condition.
- Provide an inventory sheet of all works, which is regularly updated. Each work must be labeled on the back/underside with name of artist, name of work, medium and price. Work that is not properly back labeled will not be hung.

- Participate in satellite exhibits \_\_\_\_\_(initial)
- Have works utilized for promotional purposes \_\_\_\_\_(initial)
- Have one person feature Showcase/ Reception \_\_\_\_\_(initial)

The Gallery retains the right to:

- Move art and rearrange displays without notice
- Determine appropriateness of work for exhibit

The exhibit committee hangs all works but may require artist’s assistance for shows Artists are being accepted based on the art they have provided the Art Committee. If artists wish to explore new mediums, the new work must be submitted for approval.

**Commission**

The gallery’s commission is 20% of all sales.

**Liability**

The Art Group will not incur liability for damage, theft or loss of artwork.
